*** Under the terms of the Convertible Bonds due 2011 (“First CB”), options will be granted to the converting Bondholders upon conversion of the First CB as long as such conversion takes place within 12 months from the date of the initial issuance of the First CB; which options will entitle their holder to subscribe (in cash 100% of the principal amount) for further convertible bonds with an aggregate principal amount equal to the principal amount of the First CB converted.**

**** First CB Bondholder has converted the First CB into 10,000,000 ordinary shares of the Company on 14 April 2010. At the same time, the Company has issued an additional HK\$10 million convertible bonds (“Second CB”) to the First CB Bondholder pursuant to the terms and conditions of the First CB, which allow the bondholder to convert the same into an additional 10,000,000 ordinary shares of the Company at a conversion price of HK\$1.00 each. Second CB bondholder has converted the Second CB into 10,000,000 ordinary shares of the Company on 26 April 2010.**
