On 21 July 2016, the Company entered into the Placing Agreement with Fortune (HK) Securities Limited (the “Placing Agent”) whereby the Company agreed to place, and the Placing Agent has agreed to act as the agent to the Company to procure on a best effort basis, not less than six Places, to subscribe for the convertible bonds in the aggregate principal amount of up to HK\$850 million.</p> <p>The convertible bonds can be converted into ordinary shares at the conversion price of HK\$0.65 each. On 29 June 2018, VC Global Investments Limited (the “Purchaser”), an indirect wholly owned subsidiary of the Company, entered into the Sale and Purchase Agreement with Mr. Ting Pang Wan Raymond (the “Vendor”) whereby the Purchaser conditionally agreed to acquire and the Vendor conditionally agreed to sell 100% equity interest in Bright Element Investments Limited (the “Target Company”), of which held a property in Shanghai, PRC and all obligations, liabilities and debts owing by the Target Company to the Vendor at a consideration of HK\$257,200,000. The consideration will be satisfied by way of issue of the 3-year two per cent. unsecured convertible bonds by the Company.</p> <p>The convertible bonds can be converted into ordinary shares at the conversion price of HK\$1.25 each.
